Charges and payment

- A deposit of 50% (fifty percent) of the venue hire secures your booking. The reservation is confirmed upon receipt of a signed copy of the terms and conditions, together with bank proof of payment of the deposit.
- A damage deposit as below or negotiated for smaller groups.
- Your surname and wedding date should be used as reference when making payments
- The date you choose will be booked once proof of payment is received.
- Balance of payment is due one month prior to the event.
- A R4 000 (four thousand) damage deposit fee will be charged on all invoices. The damage deposit fee is
 refundable only after breakages and or damages were assessed after the wedding, which amount will be
 calculated within 1 week after the event. The balance of the damage deposit will then be refunded to the
 client. A full inventory of the venue and kitchen will be done before and after the event.
- On site credit card facilities available.
- Marlotti reserves the right to amend its prices at any time. Rates are subject to change without notice.
- The deposit is non-refundable.

Cancellation policy

- Cancellations will only be accepted in writing and no verbal cancellations will be accepted.
- A cancellation fee of the total account will be charged depending on the lead time of the cancellation:
 - o Within 9 months prior no charge.
 - o Within 6 months 50% of total wedding account
 - $\circ~~3$ months 75% of the total wedding account
 - o Less than 3 months 100% of the total wedding account

Bar services

- We are a fully licensed venue.
- Bar prices are subject to change without prior notice.
- A list of preferred wines and sparkling wines is required at least one week prior to the event.
- Corkage fee: R40 per 750ml bottle.
- Should the client choose an open bar option, the limit is payable at least one week prior to the event.
- · No beverages may be brought onto the premises unless discussed and agreed upon with management

- Only bio-degradable confetti allowed

- Marlotti will not be held liable for interruption of services (water, electricity or sanitation) however a generator is available at a rate of R200 (two hundred rand) an hour.
